Key facts about the Foundation:

- The Foundation is 54 years old – founded in 1969
- We have partnerships across the province and nation to build stronger communities
- We are one of nearly 200 community foundations in Canada - A proud member of Community Foundations of Canada
- We have approximately \$100 million in assets
- We have distributed approximately \$60 million back to community in our 54 year history

Our concept of legacy giving is simple:

1

We take donations in many forms, including cash, stocks, real-estate, mineral rights, and more.

We then provide a charitable tax receipt.

3

Next, we protect and invest those donations.

Then, every single year we payout the interest earned to charities and causes the donors care for.

It is a disciplined approach, and a sustainable giving model, that can leave a **lasting legacy** for generations to come.

We can act as your own personal foundation *without the administrative work.*

You can start your own Foundation fund with \$10,000 (or a multi-year plan to build up to \$10,000) making this an accessible option for many families and businesses.

We hold approximately 140 funds that were started by local organizations, individuals, and families. These funds consist of memorial funds for loved ones, donor advised funds, and agency funds.
