Lorne and Evelyn Johnson were a couple whose hearts beat for the enrichment of Regina and Saskatchewan's religious, educational, and cultural life.

The establishment of the Lorne & Evelyn Johnson Foundation (LEJF) in 1962 was a testament to this dedication. Lorne, a native of Aylmer, Ontario, found his life's work in Regina, where he was involved in various business ventures and served as the general manager of Sterling Trust Corporation. Evelyn, a talented graduate of the Toronto Conservatory School of Expression, championed the role of women in Canadian society and was deeply engaged in local and provincial organizations.

Together, they were ardent supporters of Regina College, were one of the founders of the Regina Symphony Orchestra, and actively engaged in various cultural and philanthropic groups. The Johnsons passed away in 1971 and 1978, but their legacy of heartfelt contributions continues to endure today.

In recent years, our Foundation collaborated with LEJF on grants and admin tasks. An analysis of LEJF financials found they could have earned \$2 million more if they partnered with us for 10 years. If extended to 50 years, based on our historical returns, the potential additional earnings would have been significantly higher. These missed earnings represent a missed opportunity for funding essential community needs.

LEJF has made the decision to completely close their private foundation of over 60 years, and move all funds totally, close to \$7 million, to our Foundation. LEJF has retained a granting advisory committee, made up of their foundation board members, ensuring the philanthropic vision established with the LEJF will be upheld. By eliminating administrative burdens such as banking, auditing, legal filings, and associated costs, LEJF can focus on their core philanthropic objectives.
