Starting a Fund at the Community Foundation is easy.

- **1. Connect with us.** Start a conversation with our team about the different fund types and your fund purpose. We're always happy to present at Finance Committee and Board meetings.
- **2. Board motion.** The Board Motion documents the intentions of your organization to establish a fund or funds with the Community Foundation. Suggested text for the Board Motion is as follows:

[Legal Name of Organization] wishes to establish [Type of Fund or Funds] at the South Saskatchewan Community Foundation to support the operations of [Legal Name of Organization]. We approve of and authorize [Name, Title] to finalize the terms of the agreement(s) with the South Saskatchewan Community Foundation.

3. Fund establishment. Our team will work with you to finalize the agreement(s), including the name of your Fund, your Fund purpose, and the value of your initial contribution. Once signed by all parties, we will start building your Fund webpage, setting up an online donation page, and giving you access to the Fund Portal.

Types of Funds

LEGACY (ENDOWED) FUNDS (pg 4)

Donations to your charity's Legacy Fund are protected by the Foundation and create a lasting legacy that forever supports your operations.

- Permanent Revenue Source Once established, your Legacy Fund will provide stable and predictable annual grants from the investment earnings and can serve as a diversified revenue source.
- Long-Term Growth As the fund balance grows over time, as will the annual grants back to your organization.
- Create a Legacy Invest in the future of your organization and build a legacy that remains in community forever.

FLOW-THROUGH FUNDS (pg 7)

Create immediate impact in the community with a "charitable savings account." These are often used in conjuction with capital campaigns.

The Community Foundation accepts donations to your Fund, issues tax receipts to donors, and your organization can withdraw at any time.

CHARITABLE ASSETS UNDER ADMINISTRATION (pg 8)

A new and local option for reserve investment.

Charities can pool reserves with the Community Foundation and benefit from our diverse and professionally-managed investment portfolio. You earn what we earn and can withdraw your funds at any time.

In addition to the Community Foundation's charitable cost recovery fees outlined above, the professional investment management fees are shared by all funds on a strictly cost-recovery basis. Historically between 0.4% - 0.6%, these fees include portfolio managers TDAM and PH&N, as well as investment consultant George & Bell.

Aside from cash, there are many ways for donors to make an impact. We take care of all the details, issue a charitable tax receipt to the donor, and contribute the funds directly into your organization's Legacy (Endowed) and/or Flow-Through Fund.

Supporting the Leader-Post behind the scenes.

Every holiday season, the Community Foundation processes upwards of 600 individual donations in support of the Regina Leader-Post Christmas Cheer Fund. The annual campaign provides support to four local women's shelters and has become an important giving tradition since 1992.



Legacy (Endowed) Funds are a sustainable and enduring source of operational funding for your organization that continue to grow over time.

Donations and contributions to your charity's Legacy Fund are forever protected by the Community Foundation and responsibly invested as part of our larger asset pool.

Investment earnings help to grow your fund over time and each year, a portion is granted back to your organization. This stable and predictable funding can be transformative for organizations and help diversify funding sources with a permanent and sustainable funding stream.



Legacy Fund Matching Programs



Charity Fund Matching Program

Thanks to the generous gift of an anonymous donor, the Community Foundation is able to support the long-term sustainability of local organizations through the growth of Legacy (Endowed) Funds.

For every dollar contributed to a charity's Legacy Fund held at the Community Foundation, **we will contribute an additional 10%** on a quarterly basis (up to \$50,000 annually).

For the **MacKenzie Art Gallery,** an opportunity for immediate returns:

"When we launched our new Facilities Legacy Fund last year to plan for our future, the matching program had a tremendous impact," shared Executive Director, John Hampton. "A Legacy Fund is a gift that keeps giving and seeing an immediate boost through this program was monumental. Having annual disbursements that you can rely on year over year in perpetuity can be transformational for organizations, allowing us to make long-term plans and focus on delivering on our mission, and I'm excited to see how this generous program will amplify the impact of donations across our community."





Canada Cultural Investment Fund

The Endowment Incentive Component of the Canada Cultural Investment Fund (CCIF) encourages donors to contribute to Legacy (Endowed) Funds for eligible non-profit professional arts organizations.

The Canadian Heritage program provides **up to dollar-for-dollar matching** on private donations into approved Legacy (Endowed) Funds.

Increasing the impact of a donation for the **Regina Symphony Orchestra**:

When a donor chose to gift around \$10,000 of shares to the RSO Endowment Fund, their donation was immediately matched by 10% by the Community Foundation then submitted to the CCIF program. Donations of publicly-traded securities are exempt from capital gains and donating the shares (with an estimated net cost of \$3,000) resulted in nearly \$18,000 for the RSO Endowment Fund to support their operations, forever.



Legacy Fund Impact Stories

Remembering the legacy of Anne Luke.



The Anne Luke Legacy Fund was created in memory of Anne Luke, founder of the Regina Early Learning Centre. "We wanted to find a way to let her legacy live on," explained current Executive Director, Monica Totton, "so that we remember our roots and can continue to sustain the values and programming that she felt was of so much need." The Legacy Fund keeps Anne's name and vision alive and provides sustainable funding for operations and programming. For former Executive Director Mary Ann McGrath, the Community Foundation is "the perfect partner for the Early Learning Centre's Endowed Fund."

Forever sustaining the historic Co-Cathedral.




The Gravelbourg Co-Cathedral Fund was established to secure a sustainable future for the community's incredible infrastructure and cultural history.

"Our grandparents gave us this wonderful church for us to look after," shared André Moquin, Chair of the Co-Cathedral Preservation Fund. The group chose to partner with the Community Foundation to preserve the Co-Cathedral for generations to come, noting that the Community Foundation "has investment expertise and their returns are phenomenal."

Supporting wholistic health care.



The DEK All Nations' Healing Hospital Foundation Fund was established after an anonymous donor came forward with a major gift to thank the hospital for the care they had received. "They help us grow our Fund and leave legacies behind," said Tribal Chief Jeremy Fourhorns. The Legacy Fund allows for the recruitment of physicians, purchase of new equipment, and services for the benefit of all patients and the Fort Qu'Appelle community.







The Community Foundation can help reduce the administrative burden on your team, whether accepting everyday donations from supporters or fundraising as part of a large capital campaign.

Let the Community Foundation be the engine that drives your campaigns behind the scenes.

A Flow-Through Fund can be considered a "charitable savings account." As donations are made to the Fund, the Community Foundation issues charitable tax receipts to the donors.

While held in the Flow-Through Fund, assets are typically invested as part of the Community Foundation's investment pool and grow with earnings. Organizations may also elect for their Flow-Through Fund to be kept outside of the investment pool for a more conservative investment approach.

You have access to the full balance of the Flow-Through Fund and can withdraw at any time.

The opportunity is designed to help organizations to optimize their reserves through our diversified and expertly-managed investment pool while also providing full access to the funds.

Charities often choose to establish a Flow-Through Fund in conjuction with a Legacy Fund as a means of supporting operational needs in the short-term while growing the Legacy Fund as a diversified source of sustainable and long-term funding.
