One new initiative we launched is the Emergent Women and Children's Fund. Our passionate and generous guests helped us raise \$55,000 that will provide ongoing and immediate support to women and children in emergent need. I'd like to thank YWCA Regina, RaiseHER Co., and all the passionate speakers, including the new Lieutenant Governor, Bernadette McIntyre, who delivered her very first speech to 250 attendees. Last spring, the

Foundation partnered with Virtus Group to host a film screening of "UnCharitable: Reimagining the Non-profit Sector." Invited guests watched a powerful documentary that asks society to rethink the way charities are supported. One of the best compliments was from one of our fund holders who is well into their 90s, saying, "This documentary made me completely rethink how the business model for charities needs to change." Our second annual Friendraiser was an astounding success. The event connected 100 charities to over 400 caring community members. It was incredible to see so many people working towards change in a single room. It was also our honour to present the inaugural Lasting Legacy Award to the Kramer family. The impact they have made on the communities they touch is immeasurable.

I am very appreciative of the historic partnership we formed with the Lorne and Evelyn Johnson Foundation (LEJF). Our Community Foundation and the Johnson Foundation have had a longstanding relationship. We have administered the private foundation's granting efforts for two decades. In 2024, LEJF formally moved their funds under the Community Foundation's umbrella. This means we can have a bigger impact, together.

It was also an incredible milestone year. Our Community Foundation now holds over 200 Funds and counting. To put this in perspective, this represents over a 25% increase in a single year –

and we've been around for over 56 years! It is heartwarming to see so many caring families, individuals, and organizations put their trust into this Community Foundation. These new partnerships mean that charities and communities are better supported, forever.

And to top it all off, the Community Foundation is pleased to be one of the top 50 equitable Canadian funders in 2024. The Future of Good and Quake Lab project ranked us 20th out of the top 50 Canadian grantmaking foundations. We continue to strive towards equity within the workplace and amongst our partners. I would like to thank all our amazing staff and board for helping us achieve this.

Your time is valuable, and it truly is appreciated that you've taken time to read our Impact Report. Together, we can work towards strong and equitable communities for all.

Stories of Emergent Need:

She's starting over, needs to get on Saskatchewan Income Support and start looking for work, she left with only a few bags of clothes for herself and her children.

By using this Fund, she was able to use it for costs associated with moving (rent, initial deposit, rental arrears that was preventing her from finding new housing, utilities setup/arrears, moving and transportation). She also used it to purchase necessary furniture as well as kids clothing and school supplies.

The impact of having access to these funds has allowed her to find a safe, secure home for herself and her children; she's able to have a fresh start.

ABOUT THE TRUTH AND RECONCILIATION LEGACY FUND:

The Foundation's board used approximately \$600K to start the Truth and Reconciliation Fund. This was possible through a generous bequest from an anonymous donor.

The Foundation connected with key Indigenous community members to guide the Fund. The Fund provided 57 grants of over \$546K over a two-year span. It also helped plant an initial donation of \$100K to establish the Legacy Fund. This Legacy Fund will grow each year and continue to give back, forever.

The Truth and Reconciliation Fund supports charities that are addressing the Calls to Action. This includes activities focusing on Education, Culture, and Language. An Indigenous-led group of advisors make decisions for the Fund and where its money goes.

UnCharitable: Reimagining the Non-profit Sector

Film screenings to challenge the status quo.









Thank you to everyone who joined us to watch UnCharitable on March 6, 2024. Two screenings were hosted by the Community Foundation and Virtus Group.

This documentary is based on the book UnCharitable by Dan Pallotta. It is a heartfelt call to action to change the way we view the non-profit sector. It challenges traditional constraints that make it difficult for non-profits to impact the communities they serve.

The film asks us to challenge the status quo within the non-profit sector and pave the way for transformative change. We can push boundaries and create more equitable impact for all.

ABOUT DAN PALLOTTA:



Dan Pallotta has been revolutionizing the non-profit sector since 1994 and has since been working to

help change the perspective people have on how the sector is run. His successes began when he helped to create the first-ever AIDS Rides and Breast Cancer 3-Days campaigns, a brand new way to fundraise on a massive scale. They proved to be widely successful; however, concerns

began to surface regarding why the initiatives weren't receiving more of the funds. This scrutiny is a double-edged sword within the industry, as you can't have results without investing in the means to obtain them.

In Dan's well-received 2013 TED Talk, he highlights this double standard, and aims to bring awareness that taking risks is what's needed in order to make a true difference. Within the sector, organizations are expected to achieve similar successes as for profit organizations, yet are

restricted to spending little to no money in order to achieve it. This leads to non-profits being commended for how little they spend, rather than the results of their community impact.

In this bold talk, he says: Let's change the way we think about changing the world.



Vital Conversations With Regina's Non-profit Voices

Addressing funding gaps and collaborating with the City.

REGINA'S NON-PROFIT VOICES: COLLABORATION WITH THE CITY

ADDRESSING FUNDING GAPS

On September 17, 2024, the Community Foundation hosted a conversation with non-profit representatives in Regina and surrounding area that do community work related to the focus areas identified in the 'Growing Futures: Vital Signs Report 2023.' Participants were asked to identify common challenges and solutions, together.

COLLABORATING WITH THE CITY

On March 6, 2025, the Community Foundation and the Nonprofit and Voluntary Sector Studies Network at Luther College at the University of Regina (NVSSN) hosted a facilitated roundtable conversation. This took place among Regina non-profit representatives and the City of Regina's mayor, council, and administrative staff. This meeting was a follow-up to the September 17, 2024 conversation titled 'Regina's Non-Profit Voices: Addressing Funding Gaps' where the need was identified for government agencies and non-profit organizations to work more collaboratively regarding funding and policy making decisions.

Over 50 people shared ideas on how to work better together. This included Regina's Mayor, city councilors, and nonprofit leaders. It was great looking for new ways to improve our community! We look forward to having more of these sessions in the future. Thank you to everyone who attended.

The groundwork of this conversation originated from the 'Growing Futures: Vital Signs Report 2023' that acknowledges the community funding gaps that the non-profit sector is facing.

BACKGROUND TO THE VITAL SIGNS FOCUS AREAS

The 'Growing Futures: Vital Signs Report 2023' was published by the Community Foundation and focuses on a Saskatchewan region recovering from a global pandemic and adapting to an increased cost of living. The report investigates the ways these challenges are impacting our community.

Creating Accessibility with Carla Harris



Carla Harris Accessible Arts & Culture Fund

I studied to be an artist and entrepreneur. When I was mid-MBA I was diagnosed with epilepsy and it worsened to the point where I had to undergo brain surgery. After my surgery, my skills were still the same; I was still the same person with the same abilities. Unfortunately. I soon discovered barriers around the arts due to my "condition." These barriers made it difficult to work with the very same arts organizations that had inspired me to begin my journey. My diagnosis meant I was no longer able to drive, so suddenly small practical things held me back from taking part in arts events in my community. I was shocked to find myself unable to work for arts organizations either. Since so many positions in the industry were contract-based, they lacked the robust health plan that I need to cover the medications necessary for managing my health. Discouraged, I left the arts feeling certain that someone like me would never make it work, not with all these barriers popping up. There were no stories like mine, no one with whom I could relate, so deep down a part of me felt that I didn't belong there.

It took more than 10 years for me to find my voice, and I started to see that there are more Canadians living with disabilities than I had previously thought. In fact, 24% of Canadians have disabilities, and that number rises to around 40% once Canadians reach 65. I started to see that many people have additional costs and barriers that hold them back, all directly relating to their own disabilities.

It was at this point, a decade after my brain surgery, that I publicly identified as a disabled artist and entrepreneur. When I finally took that step. I began to meet other disabled artists, I found new commonalities in community. Finally, I saw stories like mine. People like me. I also learned about the social concept of disability, that society is what is holding people back, not the effects of our disabilities. This knowledge, this sense of community and belonging, has given me pride in disabled culture and has helped me refocus my lens to return to the arts with a voice more honestly my own.

The arts can impact the richness of people's lives, their relationships in their communities, their personal growth, and their mental wellness in tangible ways that are often overlooked. I have seen how invisible barriers can hold people

back from accessing the arts in their communities, and I believe that all people need to learn that we don't have to do everything independently. If we work to include everyone, if we can reduce the barriers that all people face for different reasons, we can truly make our community a more rich and rewarding place for all.

I created the Carla Harris
Accessible Arts & Culture Fund
so it can be used to alleviate the
visible and invisible barriers that
hold back artists and audiences.
I want every audience member
to see people like themselves on
the stage, the screen, in song, and
on the page. I want to normalize
asking for "help." Needing
"help" isn't a failure, but an
acknowledgement that we are all
capable of amazing things, given
the chance.

ABOUT LORNE AND EVELYN JOHNSON: GIVING OVER \$11M TO HUNDREDS OF CHARITIES SINCE THE 1970S



The LEJF started in 1962 to enhance the religious, educational, and cultural life of Regina and Saskatchewan residents. This was a way for them to continue to support activities they had enjoyed and participated in. The name of the LEJF was changed

from the Lorne and Evelyn Johnson Foundation to the Lorne and Evelyn Johnson Fund when it moved under the Community Foundation in 2024.

The couple was active in the social and cultural life of Regina. They were both active supporters of Regina College. He was a member of the Board of Directors from 1918 to 1935 when it was taken over by the University of Saskatchewan. She served on the executive of the Women's Educational Club. Mr. Johnson was a founder of the Regina Symphony Orchestra and the Regina Orchestral Society, serving as president and director. Mrs. Johnson was a governor of the Regina Orchestral Auxiliary

from 1935 to her death. She was also a member of the Regina Women's Music Club for many years.

Mr. Johnson died in 1971 and Mrs. Johnson died in 1978.

Honouring Joyce Gemmell Jessen

JOYCE GEMMELL JESSEN (1935 - 2025)

The Community Foundation staff and board were saddened to hear the news of Joyce's passing this year. We are forever grateful that her name will live on and give to environmental causes for many generations to come.

Joyce Gemmell Jessen was born in Moose Jaw during the "Dirty 30s." Her parents, Frank and Jean Gemmell, farmed near Tuxford before moving to Moose Jaw, and Joyce spent many summers swimming in Buffalo Pound Lake or at her uncles' and aunts' farms nearby.

The idea of establishing a legacy fund at the Community Foundation to promote land conservation and the restoration of the prairie ecosystem was an easy decision for Joyce.

After completing medical technologist training at Moose Jaw's Providence Hospital, Joyce moved to Chicago, Illinois where she met and married John David "The prairies are just a part of who I am – I'm a prairie girl."

Jessen. Even then, the rolling hills and wide prairie skies of her home province were never far from her thoughts.

"I'm a local girl 'done good.' This is a way to celebrate my roots, give back to the community, and to share the beauty of the prairies with future generations," she said. "Saskatchewan's native prairies are a fragile, disappearing ecosystem. In the 1930s and '40s, we didn't know what our farming practices did to the soil. We didn't understand how the roots of native grasses held the land together or how birds and wildlife depended on the delicate balance of vegetation, water, and open spaces. I'm thrilled that the Joyce Gemmell Jessen **Habitat Conservation Fund** will leverage community partnerships and greater understanding of this amazing environment."


